#### Agenda Item #5: Approval of Agenda

#### Agenda Item #6: Voter Challenge

There were 4 voter challenges, one for the wrong person selected voting during early voting, and 3 for being deceased before election day and voting an absentee ballot. First challenge was for Wanda Loretta Brown she voted on October 18, 2024 during early voting at Ransom's Early Voting Site when she voted the name selected was Wanda Louise Brown. During Voter challenge the incorrect ballot Mrs. Brown voted was pulled and deducted from count. The other 3 challenges were for Mr. John Hardwick, Mrs. Margaret Hewett, and Mr. Joseph Hinson these 3 voted and absentee by mail ballot and passed away before Election Day. seconded by Mr. Fairfax and the motion was passed. Mr. Meekins made a motion to not accept Mrs. Margaret Hewett ballot and seconded by Mrs. Thompson and the motion was passed. Mr. Meekins to not accept Mr. Joseph Hinson ballot seconded by Mr. Fairfax and the motion was passed. After the motion was passed for all 4 voter challenges Ms. Collins asked the board to call a recess so the ballots could be pulled and deducted for the count and she could finish finalizing election the board agreed and went to recess at 11:29am the board resumed at 2:14pm.
