

Public Input on Alternate Proposal:

Terry Mann, 203 Elm St., Whiteville, NC Stated:

All of you know I'm an old man and I didn't understand this concept until I went to Wilson with a group here, I guess it was two or three years ago, and learned quite a bit. Johnathan spent a lot of time and effort getting to where we are today and I saw the one in Wilmington, North Carolina and you know it is it's just a different concept in the way we work it's out of a room, but for the young people it's kind of what they're looking for. I understand believe me I understand the money situation. I just heard these figures a few minutes ago, but; if it's \$4 million and you're gonna get a \$1 million grant you are still spending \$2 million so that part I don't really understand. I just think that building there is conducive to what we call "The LAB" is supposed to look like. It's very disappointing, not as much to me because I haven't really spent that much time and effort, but there are some people in this community they have spent a lot of time with this, two and a half to three years on this thing and have been working hard and we thought, well they thought they were getting to a point where it might be a reality. Now you all have it cut down to a third of what we thought it was gonna be. If there's any way you can afford to do it. I sure would appreciate it and the city definitely would appreciate it. I think I would do it. It's a new phase of economic development, it's just hard for me to comprehend but it just the way of the future. I really would urge you to support it and they must work because I go to a lot of mayor's meetings and a lot of counties have them. They must be some benefit to it and they must be worth something. We would appreciate any support you can give this fellow who knows a whole lot more about it and he can give you a whole lot more information on what they're doing but this is just a gut feeling from just somebody looking from the outside.

Cynthia Ellis - address is 197 Fox St. Whiteville. I want to speak as an advocate for the entrepreneurial community, but I also sit on the committee on the advisory Council for The LAB and I can say that ever since I was appointed to be on that committee, my eyes were open to a vision. That was way beyond anything this county has definitely ever seen before. I've been a small business consultant and economic strategist since 2013. I started my own business and, like Johnathan, I started mine out of my house but I've been able to be a witness to what entrepreneurship can do not just to my home and what it does for my family, but for community as a whole. Since 2013, I've been able to build my business, but it was very difficult to do that on my own and If I would have had an incubator and the support and the camaraderie, Other entrepreneurs and sources like Southeastern small business, sooner my path we could've been accelerated by years, almost a decade, so where I am now, the LAB would give new entrepreneurs, the opportunity and the environment to achieve that within the first one to three years. So just some statistics for you, in America over 65% of businesses fail within the first five years but recent studies from Forbes magazine has proven that with the help of Support staff and consultants like myself that they're able to more than triple their chances of survival. Haven been in this a decade now and with the connections that I've made I can see that I'm able to give back to Columbus county which is where I grew up. In so many ways, I've been able to help over 300 businesses and thousands of entrepreneurs worldwide and I'm blessed to be able to stay here on my journey but having an incubator like this, will allow people like myself and those from Southeastern to import a lot of that knowledge into those who need it here, so as the county expands, my ask, would be that you definitely consider using this building as a space for entrepreneurs, who were like me who need to start in a place to begin their business journey becoming a lot for their families, but it can also mean a lot for yours. Also appreciate your time.

Johnathan Medford stated:

I apologize for how I am dressed, I had to come here straight from the print shop and my name is Johnathan Medford and I'm here speaking as the chairman of The LAB entrepreneurship committee for the Jobs foundation and so I also appreciate this board appointing me to sit on the advisory committee. As for starting The LAB up, the price tag the architect discussed last meeting was quite a shock. I'm sure when they gave our committee early numbers we figured we would likely only be able to renovate you know maybe the first couple floors and then maybe the third floor would have to be a later renovation project for us we can go out for additional thing. You know Gary has worked really hard securing us the Golden Leaf foundation grant of \$500,000 and you know we still have a significant

shortfall discussed tonight. Um I think the best news though is this EDA opportunity and I went for five years ago, I'm meeting with Gary to speak with a representative and this is exactly the kind of project that they fund as an incubator type project in an economically stressed area. It's still experiencing some growth there's opportunity for growth here and they recognize that and when we told them about the short fall, the response was, give me an application and we will pay for 50% of the short fall, so, before you take action on utilizing this building for other purposes, ask yourself if that EDA grant was to come through, does that change your mind? Look at spending \$2 million here if you don't do it with the original plan versus if we get the EDA form that's \$1.9 million so to me that makes a significant difference. I will also say this is just off the cuff, because after hearing this, like when we met with the Golden Leaf Foundation years ago, they brought up that there's a very successful project in Wilson, that we all toured there's also very unsuccessful Gordon Leaf Foundation project, where they took an old building, and then say this is the incubator you know, and it had no pizzazz to it. It was just a government building and that's not a place people want to come and work and it failed big time. The Golden Leaf Foundation was like, we wanted for you to see the good ones, but we want you to see the bad stuff too and that is what this looks like to me, this is bad stuff and so we need this project to happen. Right in the past year, 482 new entities have been formed here but years ago those numbers were like 250 a year, the next two were 357 the year prior to this past year was 517 so in the next years it could potentially go to 963. The need for entrepreneurship has grown tremendously but I'm telling you the need for this building to be a place where people want to be and work and grow the business is huge. I also want to say it doesn't take a lot of businesses to make a huge impact. I started my print shop out of my house in 2021, a little over a year and a half ago, six months later I moved into a 1200 square-foot office downtown, six months after that, I moved into a 2500 square-foot building, six months after that I moved into the 7500 ft., and the first floor of the old Scotty's building. I've invested over a quarter of \$1 million in startup, and my goal is not to do anything on the inside, I outsourced everything but just the volumes demanded that I grow, and invest in the company. Um, I've hired two employees the whole time that I moved here from out of the county so my little business is hoping to grow the tax base here, if you get like six or seven businesses, do that out of the lab and that shortfall means nothing. I want you guys to know the economic impact of entrepreneurs is real. This project that you guys have agreed to move forward with it at some point in some degree is innovative, it's forward thinking, it's proactive, and it's going to grow our future tax base. Just don't short change it and please don't throw away this opportunity, keep this building The LAB and give us an opportunity to go out for the EDA funds and see what happens. I would encourage you to table.

This Agreement is hereby made and entered into by and between the NORTH CAROLINA DEPARTMENT OF TRANSPORTATION (hereinafter referred to as "Department") and <u>COLUMBUS COUNTY</u>, the public agency owning the <u>COLUMBUS COUNTY AIRPORT</u> (hereinafter referred to as "Sponsor").

This agreement shall be effective on ______ and shall terminate on <u>JULY 31, 2024</u> with the option to extend, if mutually agreed upon, through a written modification. Pre-award costs included on the Code and Category of Expenditure Section of the AV-501/AV-504 of the project's Request for Aid (RFA) Application are authorized.

WITNESSETH

WHEREAS, the Department has received the approval of the Federal Aviation Administration to administer certain Airport Improvement Program Funds in North Carolina under the provisions of the FAA Modernization and Reform Act of 2012.

WHEREAS, the Department has approved a grant of funds to the Sponsor under the State Block Grant Program Non-Primary Entitlement and CARES Match funds.

WHEREAS, the Sponsor has made a formal application dated MARCH 14, 2023 to the Department for Non-Primary Entitlement and CARES Match funds for the COLUMBUS COUNTY AIRPORT; and

WHEREAS, a grant in the amount of \$62,619 not to exceed 100 percent of the federal share of the final, eligible project costs of \$62,619 has been approved subject to the conditions and limitations herein; and

WHEREAS, the Non-Primary Entitlement and CARES Match funds will be used for the following approved project:

NEW TERMINAL BUILDING

NOW THEREFORE, the Sponsor and the Division of Aviation ("Division") do mutually hereby agree as follows:

- 1) Work performed under this Agreement shall conform to the approved project description. Any amendments to or modification of the scope and terms of this Agreement shall be in the form of a modified grant mutually executed by the Sponsor and the Division, except that an extension of time and/or a reallocation of funds within the approved budget may be granted by the Division by written notice to the Sponsor. Any changes to the scope, amount, or fees with this grant agreement without first consulting your Airport Project Manager could be found ineligible.
- 2) The Sponsor certifies that it has adhered to all applicable laws, regulations, and procedures in the application for and Sponsor's approval of the Agreement.
- 3) The Sponsor agrees to comply with the "Sponsor's Assurances" contained as a part of this Agreement. The Sponsor shall be liable to the Department for the return of all grant monies received in the event of a material breach of the Sponsor's Assurances or this Agreement.
- 4) The Sponsor agrees to adhere to the standards and procedures contained in the North Carolina Airports Program Guidance Handbook and the Federal Assurances and Certifications.

Information and Reports: The contractor will provide all information and reports required by the Acts, the Regulations, and directives issued pursuant thereto and will permit access to its books, records, accounts, other sources of information, and its facilities as may be determined by the sponsor or the Federal Aviation Administration to be pertinent to ascertain compliance with such Nondiscrimination Acts and Authorities and instructions. Where any information required of a contractor is in the exclusive possession of another who fails or refuses to furnish the information, the Contractor will so certify to the sponsor or the Federal Aviation Administration, as appropriate, and will set forth what efforts it has made to obtain the information.
- 5. Sanctions for Noncompliance: In the event of a contractor's noncompliance with the Non discrimination provisions of this contract, the sponsor will impose such contract sanctions as it or the Federal Aviation Administration may determine to be appropriate, including, but not limited to:
 - a. Withholding payments to the contractor under the contract until the contractor complies; and/or
 - b. Cancelling, terminating, or suspending a contract, in whole or in part.
- 6. Incorporation of Provisions: The Contractor will include the provisions of paragraphs one through six in every subcontract, including procurements of materials and leases of equipment, unless exempt by the Acts, the Regulations and directives issued pursuant thereto. The contractor will take action with respect to any subcontract or procurement as the Recipient or the FAA may direct as a means of enforcing such provisions including sanctions for noncompliance. Provided, that if the contractor becomes involved in, or is threatened with litigation by a subcontractor, or supplier because of such direction, the contractor may request the Recipient to enter into any litigation to protect the interests of the Recipient. In addition, the Contractor may request the United States to enter into the litigation to protect the interests of the United States.

NOW, THEREFORE, the Federal Aviation Administration as authorized by law and upon the condition that the North Carolina Department of Transportation (NCDOT) will accept title to the lands and maintain the project constructed thereon in accordance with the North Carolina General Assembly, for the (Airport Improvement Program or other program for which land is transferred), and the policies and procedures prescribed by the Federal Aviation Administration of the U.S. Department of Transportation in accordance and in compliance with all requirements imposed by Title 49, Code of Federal Regulations, U.S. Department of Transportation, Subtitle A, Office of the Secretary, Part 21, Nondiscrimination in Federally-assisted programs of the U.S Department of Transportation pertaining to and effectuating the provisions of Title VI of the Civil Rights Act of 1964 (78 Stat. 252; 42 U.S.C. § 2000d to 2000d-4), does hereby remise, release, quitclaim and convey unto the NCDOT all the right, title and interest of the U.S. Department of Transportation/Federal Aviation Administration in and to said lands described in (Exhibit A attached hereto or other exhibit describing the transferred property) and made a part hereof.

(HABENDUM CLAUSE)

TO HAVE AND TO HOLD said lands and interests therein unto the North Carolina Department of Transportation (NCDOT) and its successors forever, subject, however, to the covenants, conditions, restrictions and reservations herein contained as follows, which will remain in effect for the period during which the real property or structures are used for a purpose for which Federal financial assistance is extended or for another purpose involving the provision of similar services or benefits and will be binding on the NCDOT, its successors and assigns.

SECTION A: SPONSOR'S ASSURANCES: GENERAL CONDITIONS

- A-1. The Sponsor certifies that it holds fee simple title to the property on which this project is to be constructed. In the event any work is proposed on property which has an easement or lease in the Sponsor's name, the Sponsor agrees that it will comply with the Department's conditions and receive written approval from the Department prior to any construction on such lease or easements. This condition does not apply to planning projects.
- A-2. The Sponsor agrees to operate the Airport for the use and benefit of the general public and shall not deny reasonable access to public facilities by the general public.
- A-3. The Sponsor agrees to operate, maintain, and control the Airport in a safe and serviceable condition for a minimum of twenty (20) years following the date of this Agreement and shall immediately undertake, or cause to be undertaken, such action to correct safety deficiencies as may be brought to its attention by the Department.
- A.4. The Sponsor agrees that any land purchased, facilities constructed, or equipment acquired under this Agreement shall not be sold, swapped, leased, or otherwise transferred from the control of the Sponsor without written approval of the Department.
- A-5. The Sponsor agrees that the state share of any land purchased, facilities constructed, or equipment acquired under this Agreement shall be credited to the Department in a manner acceptable to the Department in the event such land, facilities, or equipment are subsequently disposed of through sale or lease.
- A-6. Insofar as it is within its power and reasonable, the Sponsor shall, either by the acquisition and retention of property interest, in fee or easement, or by appropriate local zoning action, prevent the construction of any object which may constitute an obstruction to air navigation under the appropriate category of Federal Air Regulation Part 77, 14 CFR 77.
- A-7. Insofar as it is within its power and reasonable, the Sponsor shall restrict the use of land adjacent to or in the immediate vicinity of the airport to activities and purposes compatible with normal airport operations, including landing and taking off of aircraft, and the noise produced by such operations by adoption of zoning laws, by acquisition and the retention of property interest, in fee or easement.
- A-8. Terminal building spaces constructed under this Agreement shall be for the use of the general public. The Sponsor agrees that it will not use any space so constructed for private use, or charge fees for the use of such space, without the written approval of the Department.
- A-9. The Sponsor is responsible for maintaining an active System for Award Management (SAM) Registration and Data Universal Numbering System (DUNS) Number and ensuring that all SAM/DUNS information is current throughout the lifecycle of this Agreement, in accordance with 2 CFR 25.200(a)(2). If SAM/DUNS information becomes inactive, expired, or incorrect, the Sponsor shall not be able to do any grant related business with the FAA, including the obligation and/or

payment of Federal grant funds, and FAA may take appropriate action to terminate this Agreement, in accordance with the terms of this Agreement.

A-10. The Sponsor is encouraged to adopt and enforce workplace safety policies to decrease crashes caused by distracted drivers including policies that bar text messaging while driving company-owned or company-rented vehicles, or government owned, leased, or rented vehicles, or privately-owned vehicles when on official government business or when performing any work for or on behalf of the Government. See Executive Order 13513 "Federal Leadership on Reducing Text Messaging While Driving," October 1, 2009, as implemented by Financial Assistance Policy Letter (No. FAP-2010-01, February 2, 2010). This includes, but is not limited to, the Sponsor: (1) considering new rules and programs or re-evaluating existing programs to prohibit text messaging while driving; (2) conducting education, awareness, and other outreach for employees about the safety risks associated with texting while driving; and (3) encouraging voluntary compliance with the agency's text messaging policy while off duty. Should bids not be required on the project, the Sponsor shall submit a detailed scope of work and estimated costs prior to requesting "Grant Execution and Notice to Proceed" for undertaking the project. All plans (and alternate) shall be supported by the engineer's report. A list of deliverables from the Sponsor to the Division will be communicated with the Airport Project Manager.
- B-2. Bids will be taken in accordance with G.S. § 143-129 and all applicable NCDOT policies. The Department will approve or reject the Sponsor's request to employ a specific contractor. Sponsor will be directly notified of approval. All contractor(s) who bid or submit proposals for contracts in connection with this project must submit a statement of non-collusion to the Sponsor.
- B-3. Unless otherwise approved by the Division, the Sponsor shall not commence construction or award construction contracts on the project until a "Grant Execution and Notice to Proceed" is provided by the Division.
- B-4. The Sponsor shall submit to the Division quarterly status reports (AV-502) according to the following schedule for periods ending: March 31, June 30, September 30, and December 31.
- B-5. The Sponsor shall notify the Division of any significant issues, meetings, audits, or inspections concerning this project involving the Sponsor, contractor(s), consultant(s), and/or any interested parties.

SECTION C: SPONSOR'S ASSURANCES: PROJECT ACCOUNTING AND PAYMENT

- C-1. The Sponsor shall record all funds received under this Agreement and shall keep the same in an identifiable project account. The Sponsor, and his contractor(s) and/or consultant(s), shall maintain adequate records and documentation to support all project costs incurred under this Agreement. All records and documentation in support of the project costs must be identifiable as relating to the project and must be allowable costs only. Allowable costs are defined as those costs which are allowable under "Federal Acquisition Regulations 1-31.6, 48 CFR, 2 CFR 200.333, and OMB Circular A-87 and also referenced in the North Carolina Airports Program Guidance Handbook and the Airport Improvement Program Handbook.
- C-2. In accordance with the Compliance Supplement based on the requirements of the 1996 Amendments and 2 CFR Part 200, Subpart F, which provide for the issuance of a compliance supplement to assist auditors in performing the required audits, the Sponsor shall arrange for an independent financial and compliance audit of its fiscal operations. Description of services provided and areas served (1,603 of 4000 characters):

Columbus County Transportation operates in southeast region of NC. Columbus County is home to 55,659 residents (ACS 5-Year Estimates 2016-2020). Within the population, 19.5% of individuals have a disability, 22.1% fall below poverty level, 6.3% are zero-vehicle households, and 20% are over 65 years old. The statistics exceed the statewide average in the aforementioned demographic categories.

CCT operates demand response services, offering rural general public transportation, medical and out-ofcounty medical transportation, veterans transportation, childcare medical transportation, and Monarch Columbus Industries Transportation between 6:00 AM and 6:00 PM on weekdays (Attachment01_Columbus County Service Area Location). The fleet is comprised of 17 revenue vehicles: 11 are lift-equipped (Attachment02_CCT Vehicle List). Fares fortrips differ based on destination: \$3 (per person per one-way trip) for Whiteville & Brunswick Townships and \$10 (per person per one-way trip) for anywhere else in Columbus County.

In addition to the rural general public transportation services, CCT's facility is a Greyhound connection point.

Additionally, CCT works with the Local Partnership for Children, DSS, the Veterans Program, and Cape Fear

Collective; provides Medicaid transportation for dia lysis patients; and transports students with disabilities to

and from schools. With a mission to provide low-cost, reliable public transportation for qualifying residents of Columbus County, CCT continues to strive to provide improved customerexperiences and will be able to work towards that goal through this grant.

Section 3: Evaluation Criteria

Demonstration of Need (2,111 of 4000 Characters):

The expansion of CCT's current facility will help the system modernize and transition to more efficient and effective services. CCTaims to provide mobility and access for residents in Columbus County and will soon work with residents of Columbus County through the Cape Fear Collective who receive Medicaid but need transportation to non-medical activities. This project will allow CCT to expand the county-owned facility by approximately 789 square feet, making it better equipped for staff to work efficiently, for drivers to train effectively, and for customers to wait comfortably. Local and regional plans, such as the Columbus County CTP and Cape Fear RPO's P6.O submittal, have identified the need to invest in this facility expansion for CCT (Attachment03_EOs and Plans). Since the facility is critical to operations for CCT's demand response se rvices, which serves various disadvantaged comm unities, its rehabilitation will increase operational efficie ncies. For example, CCT must currently use part of its garage for document storage due to a lack of space in its administrative offices.

Need for Facility Modernization

The existing facility does not have space to accommodate the storage of sensitive rider information. With the expansion, a storage room will be added to hold the private, confidential files that are currently stored in the two offices and garage. While the current storage is secured as the rooms and cabinets are locked,

the space that is taken up by secure files could be used for other storage. The CCT facility also serves as a Greyhound connection point; however, the stop currently does not have a public restroom for passengers. The renovations would convert the women's bathroom in the current facility into a public, gender neutral restroom for riders and a new women's restroom would be added into the new space for CCT staff.

The CCT service is vital for low-income residents that are transportation burdened. Modernizing the facility and increasing its capacity will allow staff to continue eliminating gaps in the current network, better connecting underserved communities.

Safety

There are two major safety concerns related to the current CCT facility. The emergency exits are directly across from each other at one end of the building. This means that staff must cross the building to reach the emergency exits. The facility expansion will add an emergency exit that is further away from the current two exits and is more accessible in case of an emergency (see Attachment05 Pictures of Office).

Additionally, the staff handles sensitive, private rider information on a daily basis. In the current facility, files are stored in the two offices, and some are stored in the garage. The expansion will include a storage room for sensitive, confidential information to better safeguard sensitive and private data.

System Condition

The current CCT facility is insufficientforthe needs of staff, including training. By expandingthe facilities to add a breakroom and two offices the staff currently in the open area of the existing facility, which doubles as a lobby, will have quieter, enclosed spaces to work and take breaks. The existing conference room is also the breakroom, which impedes driver trainings. By creating a separate reliefspace for staff, including drivers,

the utility of the conference room can be maximized. Furthermore, adding two offices will allow CCT to operate even more efficiently as staff will have fewer interruptions during their workday. Improved efficiencies often result in lowered overhead costs.

SUPPLEMENTAL GRANTAPPLICATION

Enhanced Access and Mobility

Columbus Countyspans 954 square miles and is home to 55,659 people. Of the total population, 22.1% live below the poverty level (Attachment08 CCT Maps). CCT's programs and services create mobility opportunities for disadvantaged populations. Disadvantaged populations and the community in general will directly benefit from improved amenities, safety, and security at the CCT facility. In addition, they will indirectly benefit from staff being able to better serve riders when their working environment is improved. Columbus County's social vulnerability score is 0.9523 (with O being the lowest vulnerability and 1 beingthe highest). This indicates a high level of vulnerability. The Social Vulnerability Index (SVI) considers factors such as poverty, lack of access to transportation, housing cost burden, age, lack of insurance, limited English proficiency, minority, and disability status (Attachment 10 SVI Columbus). Improvements to CCT's operations will benefit the residents in Columbus County that have a high vulnerability score.

The CCTfacility also serves as a Greyhound connection point. In the expansion process, one of the bathrooms currently reserved for staff in the existing facility will be converted into a public restroom for passengers waiting to take the Greyhound bus (Attachment07 GreyhoundSchedule).

Sustainably Modernize the Transit System

The project, as mentioned in the Demonstration of Needs section, will modernize the CCT facility. CCT aims to include sustainability improvements not currently available at the current facility — seeking to promote low-water use design and to reduce embedded carbon using low-carbon building materials in the bid for design and construction.

Improve Reliability and Serve the Community

The project will improve the reliability of transit se Nice for riders by improving the productivity of staff and freeing up garage space. Documents currently stored in the garage will be moved to dedicated storage, built as part of this project.

Planning and Local/Regional Prioritization (2,793 of 4000 Characters):

The Columbus County Transportation Facility Expansion project advances goals of local and regional plans, which identify the need for investing in the transit system strategically in order to address mobility, improve accessibility, and meet the community's transportation demand.

Address System Needs

The project advances the objectives outlined in the Cape Fear Rural Planning Organization's subm<u>ittal to</u>

Prio<u>ritization (P6.O). The proje</u>ct <u>was id</u>entifi<u>ed as one that would have Regional Impact (T185281)</u> in the

P6.O submittal although it was not selected for funding (Attachment03_EOs and Plans). Additionally, the Columbus County Comprehensive Transportation Plan (CTP) identified a project that would provide more access to CCT by constructing a new two-lane extension of Legion Drive from its current terminus to US-

701, thereby creating <u>more access to CCT (Attachment0</u>3 EOS and Plans). This project was removed <u>from</u>

the Division Needs category of the P6.0 revision process though, and Legion Drive's extension was recommended to be constructed through the subdivision and developme_____nt process instead (Attachment03_EOs and Plans).

Advance Agency Goals and Address System Needs

The project also advances the NCDOT goals outlined in the NC Moves 2050 plan, which include connecting communities to statewide opportunities, maintaining a high-quality system, and providing transportation access for all (Attachment03 EOs and Plans). One strategy included in the "Connect Communities to Statewide Opportunities" objective of NC MOVES 2050 is to accelerate demand response strategies to meet the needs of the aging population and residents with disabilities. Columbus County has a higher percentage of individuals with disabilities (19.5%) than the state of North Carolina (13.4%) and also has a higher percentage of individuals over 65 (20.0%) than North Carolina (16.3%). Investing in CCT is an investment in the rural aging and disabled population. The expansion of CCT's facility also meets the objective to "Maintain a High-Quality System" by incorporating risk considerations across transportation activities. The addition of another emergency exit that is more accessible intentionally considers emergency management and prioritizes staff safety. Lastly, the expansion project meets the objective to "Provide Transportation Access for All" by connecting NC to neighboring economies through direct competitive mobility. The Greyhound stop that uses CCT's facility connects Whiteville to Charlotte thereby expanding the economic impact of the service.

This project has support from local and regional stakeholders across the southeastern NC region with letters of support from Columbus County Health Dept, Local Partnership for Children, the County Schools, DSS, The

<u>Dream Center, and NCWorks in conjunction with Southeastern Comm</u>unity College.

As described in the following section, NCDOT IMD and CCT remain authorized and eligible recipients of federal funding and free of any issues that would hinder the permitting and construction of the facility and bus equipment. Additionally, Columbus County

Transportation has worked closely with NCDOT IMD for <u>more than 20 years</u> as a subrecipient of FTA funding. Thus, CCT has the proper authorizations, resources, and processes in place to ensure the swift obligation of awarded FTA funds. CCT can obligate and implement the project within an 18-month period.

As this project will involve expansion of the existing facility, environmental clearance under the National Environmental Policy Act (N EPA) is anticipated to be an FTA Categorial Exclusion under 23 CFR 771.118(C)(7).

It is also assumed that the project would not require Section 106 consultation as the project is not likely to have the potential to cause effects to historic properties.

Lastly, NCDOT IMD would provide oversight for the procurement of equipment and construction. NCDOT IMD has a quality control process to assist with the management of the procured resources and would work with Columbus County to provide the necessary transition of the assets into their respective inventories.

As is described in the Project Timeline, the project plan consists of six primary tasks:

- 1. Project Management Ongoing
- 2. Planning Ongoing
- 3. Environmental Clearance Ongoing
- 4. Preliminary Design
- 5. Procurement Processes for Design and Construction
- 6. Final Design and Construction

Preliminary environmental screening indicated that the site is not in a floodplain and no wetlands or threatened or endangered species were identified. Based on the initial screening and successful NEPA completion (Attachment_06 NEPA Checklist), CCT anticipates the project will qualify for Categorical Exclusion.

Additionally, CCT will work with Cape Fear RPO to include this project in the Transportation Improvement Plan (TIP) and the Statewide Transportation Improvement Plan (STIP). The TIP is typically updated as needed, and the STIP is updated quarterly. Based on prior experience, CCTestimates it will be able to incorporate the new award into the TIP and STIP by October 2023.

As the project sponsor, NCDOT IMD has the technical, legal, and financial capacity to assist Columbus County in their facility expansion, as demonstrated in the most recent FTA State Management Review/Triennial Review, which received only one finding.

NCDOT IMD is responsible for administering and managing multiple FTA and state grant programs for transit providers across all 100 North Carolina counties as the designated recipient of federal transit funds. Formed in 1974, NCDOT IMD has decades of experience providing transportation opportunities to communities, responsibly managing transit grant programs, and adhering to applicable state and federal regulations. A recent update to NCDOT IMD's State Management Plan demonstrates the commitment to evolving in response to changing federal and state transit policy to best support the state's transit agencies (Attachment03_EOs and Plans).

In alignment with the Justice40 Initiative, the project will support access to reliable, safe transit for disadvantaged populations to reach essential destinations. Eleven census tracts are identified as disadvantaged due to demographics related to climate change, health burdens, training and workforce development, clean energy and energy efficiency, and affordable and sustainable housing. Within CCT's service area, 22.1% of residents live below the poverty level (Attachment06 CCT Demographic Snapshot Tool). The expanded CCT facility will provide social, economic, and environmental benefits to the County's disadvantaged communities. CCT aims to incorporate sustainable building practices in the construction to reduce the impact of the project.

The facility will also allow the existing conference room to be used for both driver and staff trainings as well as conferences and meetings with other organizations outside of CCT staff, thereby thereby promoting the system's services.

Describe the methodology used to determine the project meets the Justice 40 Initiative (935/1000 Characters):

SUPPLEMENTALGRANT

The EPA's Climate and Economic Justice Screening Tool (CEJST) along with the USDOT's Justice 40 Mapping tool were used to identify the disadvantaged communities. A total of 52,149 residents within CCT service area are members of disadvantaged communities according to CEJST. Using the Justice40 Screening tool, eleven tracts were identified with a total of 49,785 individuals that face challenges including health burdens, climate change, training and workforce development, clean energy and energy efficiency, and affordable and sustainable housing.

The estimated ridership in 2021 was 15,762 compared to 31,031 in 2019. However, as the system regains momentum followingthe COVID-19 pandemic, CCT is hopeful to return to pre-pandemic ridership numbers. Throughout the design and implementation, CCT will engage with the public and with riders in alignment with the NCDOT Statewide Public Involvement Plan (Attachment03_EOs and Plans).
