Agenda Item #7: PUBLIC INPUT:

Citizen Howard Lofton Cox Jr. commented:

- I live in the Dothan section number one this is development I'm talking to you about the development tonight and infrastructure what I'm talking about is this next to my home they are presently building 900 homes on both sides of the Road just announced a permit for 100 homes on Marlowe Road now we talking about 19 if you go a mile from that you got 4,000 homes to be put in that's right at 6,000 homes within a mile you got 10,000 homes supposed to be put in on 905 at the state line, but I tell you what, I am giving you a little history lesson, in 2007 Horry County planning board and commissioners in Horry County Council approved 13,000 homes between Longs and Loris I followed this pretty closely you doubt me dig it up I'm not making this up what was what they had to once that development was approved is the developer had to build schools and parks for the people now when you talk to the county I see on Facebook where we talking about development, they say the tax base is going to increase well guess what it was going to increase in Horry County too but you were getting parks and schools built from this development. This county is getting nothing from the developers, nothing at all, except the tax base. Once the homes are built, if any parks are built, it's going to come from taxpayers. If you go to Brunswick County you got five really nice super parks over there for the people to use. There's no County Parks here in Columbus County, you've got city parks. I'm challenging this Board of Commissioners to work out some something where you can get something from these developers when they build this to help the people once the development is finished and they got the money and gone. Stores, buildings, and things like that will come from people that want to make money. The people that's here will have nowhere to go, nothing to do, unless it's funded by taxpayer money.
- As a taxpayer I am kind of appalled really appalled to see what was in the newspaper last week \$240,000 right a quarter of a million dollars that the board of education committed on to buying land that had never been appraised and they hadn't done anything with it. I don't think there is a member on this board that should spend that kind of money on something like that. This needs to stop, the school at Tabor was over built look at the capacity of the school and look at look at what's in there that's \$9 million something needs to stop.

Citizen Ervin Kreutter commented:

• I live in Oxford Village, Tabor City um just today I'm finishing work on a book I've got a lot more stuff to consolidate than I can on my own so I'm going to make some compromises to get the book out but I've got models that can see into the future that lay out a space where if you do this and do that and do the other that'll happen and um uh could have publish them sooner but frankly some of what I'm going to publish will go to Ai and if we're all standing around we won't get the use of it that's the reason I haven't published here before things are

getting desperate and we need a chance at this stuff um so I'm looking at hedge funds and private equity and their definitions what they do these people have organized the system to take to to undermine the standard of living of Americans across the board and they're in Europe they their business model is to squeeze wealth out of an organization and and move away and and if they fail they they have a system schemed that they bring in the richest people the biggest people the biggest organizations money then then so that they know they can't fail the 2008 bailout was essentially of head funds and private Equity bad decisions where they squeezed wealth out of people and companies and it was going to flop and to my knowledge nobody really caught up with this so we we these people have very sophisticated deals going on so it's complicated lot's going on but the end result is theft and um deception and we have um antitrust laws that have just been abandoned so um these people are on the verge I'm not going to put my weight behind it but there's all kinds of YouTube testimony by people and you can get paid on YouTube for bringing in people to watch I mean all kinds of people I call them doomsayers and don't really much appreciate them but telling us that this Market could crash and the last time we had one a big one we lost the country about a year ago I learned that 10 million people starve to death I'd never heard that before this isn't something we want to mess with and as I speak to you tonight we're now prepared to fend them off.

Mayor Terry Mann commented:

• Terry Mann, 203 Elm Street Whiteville. First of all, I came to personally thank you for letting me take part in the ceremony Friday at the courthouse. It was a remarkable event, but the real reason I came, is on behalf of The City Council and the citizens of Whiteville. I want to thank you and all that were involved in doing what y'all did to that building. If anybody that was there, at that ceremony or took the tour of that building, and was not proud of what they saw, I think they need to move to another County, because I mean it just gave me chills to sit there in that room and look at that building and see what's been done with it. I just appreciate you preserving energy, I mean, history and Mr Dixon, the architect, said one thing that really made a lot of sense. I believe it, if somebody closes their eyes, now especially a resident of Columbus County, and hears the word Courthouse, that's what they should see, so thanks again for what y'all did.



AGREEMENT FOR THE PROTECTION, DEVELOPMENT AND IMPROVEMENT OF FOREST LANDS IN **COLUMBUS COUNTY** NORTH CAROLINA

THIS AGREEMENT is made under the authority of Chapter 106, Article 75, of the North Carolina General Statutes, including N.C. Gen. Stat. § 106-906, titled "Cooperation between counties and State in forest protection and development," by and between the North Carolina Department of Agriculture and Consumer Services (hereinafter called the Department), party of the first part, and the Board of Commissioners of COLUMBUS COUNTY in the State of North Carolina (hereinafter called the Board), party of the second part.

WHEREAS, the Board recognizing the need for active forest protection, development, reforestation, management and improvement in **COLUMBUS COUNTY** has accepted the offer of the Department for cooperation in accomplishing this object; and

NOW, THEREFORE, in consideration of the mutual covenants hereinafter set forth, the parties contract and agree to maintain a legally appointed and equipped Forest Service office to support said county at the joint cost of the State and County, insofar as the joint funds will permit, as follows:

Part I. THE DEPARTMENT AGREES:

- 1. To select and employ permanent and temporary position(s) in order to successfully execute the mission of the NC Forest Service and to support the forestry program in said county. These positions include:
 - A) <u>1</u> County/Area Ranger(s) assigned for the purposes of controlling forest fires in said County; for detecting and extinguishing fires that break out; for investigating the origin of forest, woodland, and field fires; for enforcing the State's forest fire laws; for taking such preventive measures, educational

- and otherwise, to prevent forest fires; for developing and improving the forests through reforestation, promotion, and practice of Forest Management practices; and for protection of forests from insects and diseases.
- B) 2 Assistant County Ranger(s) for the purposes of assisting under the direction, supervision, and/or oversight of the County/Area Ranger in controlling forest fires in said County; for detecting and extinguishing fires that break out; for investigating the origin of forest, woodland, and field fires; for enforcing the State's forest fire laws; for taking such preventive measures, educational and otherwise, to prevent forest fires; for developing and improving the forests through reforestation, promotion, and practice of Forest Management practices; and for protection of forests from insects and diseases.
- C) **0.17** Forestry Management Clerk for purposes of providing administrative support, serving as the backup administrative contact for the assigned district, counties within the district, or unit, and serving as the primary contact for forest management administrative business within the assigned district.
- D) 3.17 Forest Fire Equipment Operator(s) for purposes of establishing fire suppression control lines in assigned work areas and in other areas as needed using equipment, including crawler tractors (fire dozers), with various attachments, such as a fire plow, hurricane blades, etc., and operate and maintain all types of heavy site preparation equipment.
- E) Temporary position(s) on an as-needed basis.
- 2. To furnish position(s) so employed a badge of office, stationery and report forms, instructional posters for use in the County, leaflets for distributing to landowners and others; to purchase necessary equipment, communication systems, and other Forestry improvements insofar as the joint funds will permit.
- 3. To pay the identified position(s) for all official services rendered at a fair rate of pay. Rates of pay are to be established by the Department in accordance with existing State salary administration policy.
- 4. To direct, supervise, instruct, and inspect, through its agents, the work and conduct of each position, to discipline and, when necessary, discharge such position(s).
- 5. To submit to the Board monthly, or at other mutually satisfactory intervals, an itemized statement of all monies to be paid by the County and those paid by the Department for the work conducted pursuant to this Agreement within said County.

State Funding

6. To make available annually from State, Federal, and other funds allotted to it, the sum of <u>Four Hundred Seventy Nine Thousand Thirty Nine Dollars</u> (\$479,039) as its share of an annual budget of <u>Seven Hundred Ninety Eight Thousand Three Hundred Ninety Eight Dollars</u> (\$798,398) for carrying on the above listed work in said County.

Part II. THE BOARD AGREES:

7. To pay the Department <u>40</u>% of the total cost of the salary of position(s) specified in Part I.1 above and expenses and other proper expenditures made in connection with the overall forestry program in said County, upon receipt and consequent approval of the periodic statements submitted by the Department.

County Funding

8. To appropriate annually the sum of <u>Three Hundred Nineteen Thousand Three Hundred Fifty Nine Dollars</u> (\$319,359), which sum shall be available for expenditure under the terms of this Agreement, and shall represent the County's share of the annual budget for carrying on work listed in this Agreement in said County.

Part III. IT IS EXPRESSLY AGREED AND UNDERSTOOD BY BOTH PARTIES:

- 9. That this Agreement becomes effective July 1, 2024, and lasts through June 30, 2025.
- 10. Payments made for services rendered in a prior contract period will apply toward the contract period in which the services were rendered and not toward the contract period when the payments are made.

That the annual appropriations as set forth above may be revised in writing by mutual agreement between the Department and the Board, based on the amount of annual appropriation desirable for the proper conduct of the Forestry work. Such revision shall become effective at the beginning of the stated Fiscal Year. The Fiscal Year begins on July 1 and ends on June 30. Any unused balance of County funds remaining at the end of a Fiscal Year shall revert to said County unless otherwise mutually agreed upon by both parties.

- $11. \hspace{1.5cm} \textbf{That this Agreement may be modified only in writing and upon execution by both parties.} \\$
- 12. That the Board reimburse the Department as provided in Part II of this Agreement by forwarding a county voucher drawn in favor of the Department for the amount of the County's share of expenditures as set forth in the Department's monthly

- statement to the Board. That such payments be made by the Board within thirty days following receipt of the Department's billing.
- 13. The title to all improvements and equipment purchased and/or constructed in connection with this Agreement will rest with the Department; such materials or their equivalent will remain in the County as long as this Agreement is in effect, or as long as they are needed by the Department for the proper conduct of the work therein.
- 14. That the County/Area Ranger periodically or at the request of the Board, shall present to the Board statements of the work being done within the County, so that said Board may be always informed regarding the Forestry finances and activities within the County.

A. Board of Commissioners

Commissioner Watts commented:

- I don't have much to say tonight um everyone's already said how nice the courthouse is. If you all haven't seen it, you need to go look at it. Someone said it's the people's courthouse and it's something to be proud of.
- The next thing would be the tropical storm or whatever it comes out to be. Please be safe and if it's flooding don't drive at night stay at home, you would probably be better off.

Commissioner Coleman commented:

- County employees are working hard they're working hard for the county and trying to keep it going I appreciate that thank you for all you do.
- There will probably be lot of flooding going on. I think they call them for about 12 in of rain Minimum, so if you can't see the highway, don't drive across.

Vice Chairman Byrd commented:

- Mr. chairman being they been short I might run over three minutes.
- Miss Amanda I understand that you have looked for some right away agreements and some maps showing that there was a 60ft easement on Loop Road. I have met with Mr. Cox and Mr. Clark on numerous occasion. The other afternoon, I got a call he wanted me to come down and I circled the road and picked up a gentleman that called me and we rode and looked and something's got to be done. If we have a 60 foot right away, I'm not sure Mr. Cox, Mr. Drew Cox, and Mr. Clark is aware that some of those have some right of ways that were put there years ago, because an easement is all the they need. I don't know what angle we need to pursue to get this handled, but I could open my truck door and water would run almost run in my truck door. Nice homes flooding under it and everywhere and crossing the road. There's a ditch between it, now this is a completely U road thats why it's called a loop road but it's just like a big U and the water is coming all the way from, I followed it from highway 74 through the little ditches and the different ways to get into the Loop Road and it has to cross it to go on to the branch there at Buckhead. I want to ask that we proceed to do whatever we can, even to the point I will post the bond myself, if that can be done to help the state go ahead. In the years back, that's what you had to do, I don't know if you can now or not. The person that's mainly holding the road up, I think, is about 89 years old. I'm not sure that he actually himself owns any of the property and it may be that the property's already got an easement across it, because this road has been a problem since back in the 80s. That is when I served on the board between 86 and 90. That is the road we worked on it and I remembered getting a Mr. Mott to sign the right away. I hope they did record it. We need to really address it and let the state know what we have and that may help them go ahead and proceed with it.
- I rode down 21 going north and on the same road, Blacksmith Rd, the water was backed up kind of like doorsteps because it couldn't get through the culverts, you know you all of us have seen culverts with dirt piled up right at the end of them. Some maintenance there on 211 would take the water out of those yards. We need to do everything we can do to address that issue.

Commissioner Smith commented:

• I'd just like to bring up the Courthouse again and like they said it was basically free and when you see Brenden Jones thank him.

Commissioner Featherson commented:

- I too am very proud of that Courthouse um and I was also very thankful for print that they gave us I will forever keep that and probably pass it down to my kids. It was really a proud moment for me, as I stated earlier, I started working at the tax office there in my early 20s so it it is a great change.
- The tax notices have been sent out or are going out and in the envelope there is a way for citizens to divvy up how they pay their taxes, so that's a great way of getting it paid without hurting them too much. I also got a call from someone asking about the service fee if they paid online so I was asked to um see if the county can check out other uh vendors who may do it for free or do it for a lesser fee so I don't know how that would work but anyway um tax notices are out and um it's a good time to start paying on them.

• I like to say a shout out to Frank Southern from The Hearts Foundation they did a back to school supply for kids over in Chadbourn and Sheriff Department employees were involved as well and the mayor of Chadbourn, so I like to just give a shout out to them, I think they packed hundreds of backpacks for kids. There are other drives going on so if you can help please do so.

Chairman Bullard commented:

• I'd like to just say thank you to this board right here for working together over the past three years and working very smoothly through the courthouse and getting it done. It speaks a lot of the ones that were involved, the County Manager, Judge, and the Clerk of Court, we all came together and used common sense and we moved forward without no trouble and I thank each one of you for that.

B. County Manager

County Manager Eddie Madden commented:

- I will piggy back on that. I think this Board needs to be commended for its participation in the courthouse project, also, as Commissioner Byrd mentioned, the \$1.9 million that was appropriated from the Georgia Pacific sale. The total project cost to date for the courthouse is \$7.94 million, so roughly \$8 million. This board has committed some dollars toward it and it was a wise investment. It brought back the building to life certainly made a significant impact on the town or the city of Whiteville, and every taxpayer will be very proud of it, so, kudos to all of you for your vision. I also want to say thank you to our staff who worked very hard during that project that the Chairman has alluded to that and some of you have as well. I'd like to recognize Stuart Carroll. Stewart worked as our unofficial project manager, he was the liaison between the contractor, architect, the Clerk of Court's office, and the County, to make sure that project went very smoothly. There were a number of people behind the scenes working on that from Grant Administration to Finance and certainly our office staff as well and then of course a number of our folks participated in in the event on Friday and that can't be overlooked and I want to express my appreciation to them.
- The next thing I want to mention is the audit is complete we did successfully get the audit transmitted to the local government commission by the 31st. We're very pleased about that I did receive confirmation from Leanne and she will be presenting the audit report to the board at your next meeting, August the 19th.
- I know the hot topic of the day is the storm that's pending and it's, of course, at our doorstep. We have had a couple of briefings today and I'll say more in a minute about that, but I do want to call on if David Ransom or Nick West would like to give a quick update on the progress of the storm.

Assistant County Manager Nick West gave the following update on Tropical Storm Debby:

- We are obviously going to experience if the projected path uh comes our way as as this forecast we're going to have an extremely excessive amount of rainfall over a long period of time uh a period of 48 hours is what is forecasted for a slow rainfall over like I said a for period of 48 hours which is going to obviously contribute to uh flooding Rivers um and such so uh flash flooding dangers so we've been meeting with State officials and our local officials here in the county have anticipated that the storm is going to arrive here in Columbus County, the most severe part of the storm, on Wednesday into Wednesday evening and then into Thursday. There's going to be a period of about 48 hours they were we're impacted by this by this rainfall wind gusts up to 45 to 50 miles an hour but the problem is as a storm comes off the coast of Florida into the Atlantic Ocean it's going to slow down this to approximately four to five miles per hour so obviously that's the problem that the storm is not going to come and get through and get on out. As it approaches North Carolina it's going to increase in rain and also about 5 miles per hour, based on what they're forecasting.
- We have been meeting with our County staff the EOC is scheduled to open on Wednesday at noon and, so we'll be operating a partial activation on Wednesday at noon we'll be sending updates and completing situational reports as we go along, starting tomorrow. We have sent out one this afternoon, a brief situation report, but tomorrow we'll be sending out a full situation report.

- I encourage everyone to stay inside and try to mitigate the hazards of Road flooding and River flooding so um I'll take any questions that you have.
 - Commissioner Watts Responded:

Nick the um the gauge that we're supposed to put in at the Waccamaw River is it up? The one that measures the depth of the river?

County Manager Eddie Madden stated that it had just been recently been installed and he doesn't think that the one Commissioner Watts is referring to is installed just yet.

Nick West responded:

There's a website I can get that website for you that shows the water gauge um level like you said what about two meetings ago we approved the funding for I didn't know if it was already installed or not it's highly unlikely it's been installed but I don't think it will be much longer yeah obviously the problems that we're facing now with the rain that we've already received the rivers are at elevated levels the ground is saturated even with the ground wet like that even you know 40 50 m hour winds gust is going to bring some trees down so we're expecting some power outages as well so um it's going to be a tough go for the next uh 72 hours now where will our shelter be yeah we're planning it potentially planning to have one shelter yes sir and we'll expand as needed.

County Manager Eddie Madden continued:

- Just a few more things, Mr. chairman, thank you uh we were notified by the Department of Aging that no congregate meals will be served after tomorrow for the remainder of the week they will be delivering meals to homebound individuals, beginning tomorrow, they will have a five-day supply that will get them through at least Sunday.
- Mrs. Edwards told me today that we will be position positioning two water department employees down in the Delco area just in case roads become impassible, so they can monitor Wells and lift stations in that part of the County. Water billing will not be impacted, so bills will go out as normal. We happen to be falling on an off week for the billing cycle, so that will not be impacted.
- We will maintain essential staff so as you've heard Mr. West indicate, that we will have a partial activation, so all of our EOC Representatives, School Systems, Attorney's Office, Administration, and Finance, all the Departments that have EOC responsibilities, will be on hand beginning Wednesday. We are going to be in this building or over at the Emergency building next door in the EOC and then depending on our ability to open the offices we will at least call in um essential staff and ask that the non-essential employees remain home where it's safe for them and their families. It is possible that some services will be temporarily impacted by the event if there are high winds that are associated with this there are protocols in place for that and we will adhere to those protocols so our purpose and our priority is to maintain the safety and well-being of our employees and our citizens um and we will we will do everything within our effort uh to make sure that that is accomplished. State of Emergency was declared a few hours ago, so it's very likely that we will have to call the Chairman in at some point this week to enact a local State of Emergency. We sent out a press release this afternoon so that information is readily available to our residents and we will post information on our Facebook page and social media platforms regularly as events as the storm evolves and we have more information available.
- We pray for everyone's safe and wellbeing we're hopeful that this storm will stay off the coast, but if it does not, we will be ready and we will provide you the services that are necessary for our citizens.
